#### I. Convene Open Session

#### b. Approval of the FY2025 Year-End Transfers

#### c. Budget Planning Review

John Bryant presented on budget and capital planning. Mr. Bryant addressed the college's current financial stewardship principles touching on the current board guidelines and considerations. Mr. Bryant then continued reporting on budget planning, presenting a budget planning background, economic factors, budget objectives, and future budget considerations.

# d. Capital Planning Review

Mr. Bryant also presented on capital planning, including highlighting debt options, capital projects (both committed and identified projects), funding options, internal funding, and funding strategy.

# 2. Chief of Staff and Vice President of Strategy

#### a. RISE 2030 Overview

Dr. Toya Webb presented an overview and update on Waubonsee's strategic plan, RISE 2030, that was launched in February 2025, and will guide the college's work for the next five years. Over 160 employees volunteered to be part of the RISE 2030 Infrastructure that includes Priority Leads, Goal Champions, Action Team Members, ATD Data Liaisons, and IT Partners. Two goals were identified for each of the four priorities, with corresponding strategic actions to help achieve those goals. Dr. Webb reviewed the various events that have already taken place during the plan's implementation, and highlighted upcoming launch events.

#### b. <u>Technology Plan</u>

Terence Felton, Chief Information Officer, shared the work his team is doing to support the college's ability to implement our strategic plan. The Technology Enablement Plan outlines the most pressing priorities, projects, and processes that will support the digital transformation at the college.

# c. Enrollment and Strategic Enrollment Management Plan Updates

Stephanie Wennmacher, Executive Director of Marketing and Communications, and Faith LaShure, Dean for Admissions, presented a new Strategic Enrollment Management Plan, which is a comprehensive strategy designed to increase student recruitment, retention, and graduation of our students.

#### d. RISE Metrics

Dr. Stacey Randall, Executive Director of Institutional Effectiveness, Innovation, and Planning, shared how we will use metrics for tracking progress and measuring its impact. A new RISE 2030 Strategic Plan Dashboard will be launched this fall on Waubonsee's public website so the community can also explore our progress and performance on our shared institutional goals.

# 3. Vice President of Community Engagement and Executive Director of the Foundation

#### a. Foundation Update

Dr. Melinda Tejada provided an update regarding a potential naming opportunity for one of the facilities at the Sugar Grove Campus. Some options were discussed, but the board requested additional information, along with a review of the process and policy in greater depth.

#### V. Executive Session
