Your salary for the first year of this contract will be \$346,413. Salary for subsequent years will be subject to an annual review.

In addition, you shall receive an additional life insurance benefit of one times annual salary, 403b contribution of \$26,000, 457b contribution of \$26,000, and the required SURS contribution paid by the Board of Trustees.

Your appointment to the staff of Waubonsee Community College, Community College District 516, is subject to all of the provisions of Illinois law pertaining to such an institution and to the lawful rules and regulations of the Illinois Community College Board and of Community College District 516 that are currently in effect or hereinafter revised or adopted.
