I. Convene Open Session

Dr. Christine Sobek, President, provided a brief review of the agenda for the day.

A. Student Equity and Success: Definition, Data, and Deliverables

1. Definition

Bernard Little, Chief Diversity Officer and Dean for Students, presented on equity, diversity, and inclusion and how these terms are defined at Waubonsee.

2. Data

Dr. Jamal Scott, Vice President of Strategy and Community Development, shared data related to student equity and showed how data is used to identify barriers, make informed decisions, track our progress, and measure effectiveness.

3. Deliverables

a. Student Onboarding Process

Dr. Scott Peska, Assistant Vice President of Student Services and Alumni Relations, and Mark Dale, Jr., Director of Registration and Records and Registrar, shared an update on the college's new student onboarding processes.

b. Developmental Education Reform

Anita Moore-Bohannon, Executive Dean for Academic Support, provided information on statewide reforms in developmental education and discussed programs in place at Waubonsee to improve student persistence and completion with more accelerated options and increased support.

c. Online Course Navigators

Ms. Moore-Bohannon shared information on the college's new program to establish online course navigators to partner with faculty to assist students in online courses in an effort to help students stay enrolled and engaged with online learning.

B. Financial Strategies and FY2022 Tuition

Douglas Minter, Vice President of Finance and Administration, and Darla Cardine, Assistant Vice President of Finance, presented an update on financial strategies and FY2022 tuition. The board of trustees supported the Operating Fund net position guideline, the tuition pricing philosophy, not increasing the FY2022 in-district tuition and fee rate, and full abatement of the 2020 bond and interest tax levy. Maintaining the current in-district tuition and student fee rates for FY2022 and the abatement of the 2020 bond and interest tax levy will be presented to the board of trustees for approval at the February 17, 2021 board meeting.

C. Enrollments and Community Needs Assessment

Dr. Scott and Dr. Stacey Randall, Dean for Institutional Effectiveness and Title V Project Director, provided a mid-year enrollment update. In addition, strategic recommendations, considerations, and key findings were shared as a result of the Fall 2020 Community Needs Assessment survey.

D. Waubonsee Community College Mission Statement

Dr. Sobek and Dr. Scott presented an overview of the current Waubonsee Community College Mission Statement and discussed a review process to ensure that it is still relevant and accurately reflects the needs of our community. The board of trustees supported a review of Waubonsee's Mission Statement in the upcoming months.
