The primary responsibilities of the Grants Office are:


- Researching grant opportunities relevant to the college's programs and strategic goals.
- Working with college personnel to identify and cultivate public and private funding opportunities.
- Assisting college faculty, staff, and administrators in planning, developing, and managing private and public grants in accordance with all State and Federal grant compliance regulations.
- Managing the grant administrative review and approval routing process to ensure that
  all grants are reviewed and approved by the departmental Dean, the Assistant Vice
  President and Vice President of the grant's departmental area, the Director of
  Financial and Auxiliary Services, the Executive Dean for Institutional Effectiveness,
  and the President, as required.
- Monitoring and evaluating the implementation of funded grant projects, maintaining required records and documents related to funded projects, and overseeing submission of required reports.
- Identifying and monitoring key post-award performance metrics for all grants.
- Overseeing the use and maintenance of the Amplifund grants management system.
- Providing support and resources for Grant Project Managers to ensure that the college is meeting stated performance outcomes, fiscal/budget requirements, programmatic/fiscal reporting requirements, and grant compliance regulations.




