# FOUNDATION UPDATE MARCH 2024

#### COLLEGE PRESIDENT'S REPORT

Dr. Brian Knetl, College President

Dr. Knetl shared updates on Mr. Daniel Jaquez's appointment as Trustee; the college's commitment to a forward-thinking outlook; the partnerships with Huron Consulting Group and Achieving the Dream; the Food, Family and Fitness initiatives; the new CTE building; and the three executive searches. In each instance, he also suggested ways that Foundation board members can support the work of the college.

#### **BOARD PRESIDENT'S REPORT**

Edward Keating, Foundation Board President

Mr. Keating returned from the AGB Leadership Forum with a host of fresh ideas. In order to equip board members to be effective ambassadors for the Foundation, future quarterly meetings will focus less on reports and more on education and discussion, with speakers from across campus and a new emphasis on data. Mr. Keating will ask the Executive Committee to consider moving to a consent agenda, and a checklist of governance issues will be shared with the full board. A draft MOU will be brought to the full board in June.

All board members are encouraged to schedule one-on-one meetings with Ms. Donatille, the new Director of Development, and to take advantage of upcoming educational opportunities. These include the AGB seminar series Collaborating for Fundraising Success and the April 30 Foundation board workshop, which will consist of a two-hour working session led by Ms. Donatille, Mr. Bryant, and Dr. Tejada, followed by a social gathering.

#### **EXECUTIVE TREASURER'S REPORT**

As of December 31, the Foundation had total assets just under \$7 million, with total contributions of roughly \$147,000 from July through December. Scholarship payments are slightly ahead of last year's.

The Foundation's quarterly meeting was held on March 5 at the Sugar Grove campus.

#### **DEVELOPMENT OFFICE REPORT**

Ms. Donatille has been meeting with Foundation board members and with deans, department directors, and others across campus to begin building relationships and to gain an understanding of the college as a whole.

She's also begun digging into data, looking, for example, at the Foundation's "LYBNTs" and "SYBNTs" (donors who gave "Last Year But Not This" or "Some Year But Not This"). She has begun drafting a stewardship matrix to formalize level of recognition according to level of giving.

As of January 1, the department is also now responsible for alumni relations. The team continues to build capacity: Ms. Robin Borgione is now full-time; Ms. Angela Way now provides administrative support; and Ms. Karen Marker now focuses on board engagement and prospect research.
