### **General Information**

#### **Dates and Times**

The majority of Xcelerate sessions are one week, Monday through Friday. Notable exceptions are Horseback riding which is a three-day experience, operating Tuesday - Thursday, and Theatre Arts Academy which is two weeks in length and has additional performance dates and times (see full schedule for details).

All Xcelerate camps are 1/2 day sessions. Morning sessions run from 9:00 a.m. - 12:00 p.m. Afternoon sessions run from 1:00 p.m. - 4:00 p.m.

If you would like your child to have a full day camp experience, you may register them for Relaxation Station which runs from 12:00 p.m. - 1:00 p.m. For flexible drop-off and pick-up times, you may register your child for Early Care which runs from 8:00 a.m. - 9:00 a.m. and Extended Care which runs from 4:00 p.m. - 5:30 p.m.

Preschool camps are only offered in the morning session.

#### **Camp Locations**

Xcelerate camps meet at one of the following locations:

Aurora Fox Valley Campus - Medical Careers Camp only 2060 Ogden Avenue, Aurora

Huntoon Stables - Horseback Riding Camp only 507 Oak Street, North Aurora

#### Registration

For general questions regarding registration, please contact the Waubonsee Records and Registration office at (630) 466-2370.

The youth registration form along with registration instructions can be found at **www.waubonsee.edu/xcelerate.** Please note that all campers must be registered prior to attending any Xcelerate programs. Instructors cannot accept registrations in class or admit children who are not on their roster.

Registrations for camps that have already started will not be accepted.

If you FAX a registration late Friday, Saturday, or Sunday for a program that begins on Monday, please contact Registration prior to the start of camp to ensure that your registration forms have been received and processed, then inform the Community Education office at (630) 466-2360 so we know to expect your child. Community Education staff will need to confirm enrollment before your child can be left at Xcelerate.

#### **Waiting List**

At this time, Waubonsee Community College cannot accommodate a waiting list for Xcelerate sessions that have filled. If your desired session is already filled, it is recommended that you continue to check for availability as students may drop the course and leave availability in the course.

#### **Camp Cancellations**

Every effort is made to avoid the cancellation of Xcelerate camps. However, camps may be cancelled due to low enrollment, instructor illness or other unavoidable issues. Camps with low enrollment will be cancelled at least four calendar days prior to the start date. A full refund is provided if a camp is cancelled in advance of the start date by Waubonsee Community College. A pro-rated refund is provided if a currently running camp is cancelled by the college, and it is unable to be rescheduled.

#### **Refund Policy**

If a student drops an Xcelerate session four or more days prior to the start of the session, a full refund will be issued.

If a student drops an Xcelerate session less than four days prior to the start of the session, a written Student Appeal form must be submitted. The form will be reviewed by committee to determine whether or not a refund will be granted. The appeal form can be found on the Waubonsee website. If a student drops a course less than four days prior to the start of the session due to a medical emergency, a written doctor's note is required for a refund.

Pro-rated refunds cannot be given to students who miss one or more class sessions for personal or other reasons.

# Required Waiver, Agreement, and Release - Changes for 2018

The general liability waiver is contained within the Community Education Youth Programs Registration Form found online at www.waubonsee.edu/xcelerate.

For students to participate in the Xcelerate program, students must return the detailed student information form, photo release, and medical waiver that are included at the end of this packet. # Health and Safety at Xcelerate

## Drop-Off and Pick-Up Policies and Procedures - Changes for 2018

Parents, guardians, or a designated adult are required to escort their students directly to and from their Xcelerate classrooms.

Adults will be required to sign their student in and out of their Xcelerate session. If you would like your student to be able to sign themselves in or out of Xcelerate, please contact the Community Education office at communityed@waubonsee.edu for the Drop-Off/Pick-Up Waiver.

If there are individuals who are **NOT** authorized to pick-up your student. Please information the Community Education department at communityed@waubonsee.edu or (630) 466-2360.

Students may be dropped off up to 10 minutes before the start of their camp start time. Students who need to be dropped off sooner will need to be registered for an extended hours session. Students must be picked up by 10 minutes after the completion of their Xcelerate session. Students who need additional time for pick-up must be signed up for an extended hours session.

If your child is registered for any of the extended hours sessions (Early Care, Relaxation Station, or Extended Care), your student will be escorted by staff to or from their Xcelerate classrooms. The Instructor for these sessions will serve as the designated adult to sign your student in or out of their Xcelerate sessions.

#### **Special Needs and Accommodations**

It is our goal to try to accommodate and include students of all abilities in Xcelerate. Please include any helpful information on how we can support your student on the required Student Information Form at the end of this packet. You are also welcome to contact the Community Education Department at communityed@waubonsee.edu or (630) 466 -2360 to discuss your child's needs in more detail.

While every effort is made to provide reasonable accommodations for students, please note that personal assistance with mobility around campus, eating or using the restroom cannot be provided by Waubonsee staff or instructors.

#### **Conduct and Behavior Expectations**

Students are expected to behave in ways that help maintain a safe and positive experience for all. Students are expected to follow instructions and guidelines that are outlined by the Instructor. Other general rules include treating others with respect, following directions, being responsible for and in control of your behavior and actions.

If a camper exhibits behavior challenges, the instructor will first work with the camper to try to correct the behavior. Ongoing or extreme behavior will be discussed with the parent/guardian and may result in expulsion from the program if the situation cannot be resolved.

The following behaviors are not acceptable and may result, at the sole discretion of the Dean for Community Education or designee, in immediate expulsion from the Xcelerate program without advance notice or refund: endangering the health and safety of self or others, theft or damage to the property of others (including Waubonsee equipment), bullying behavior (includes physical, verbal, or emotional), and/or obscene behavior or language.

# **Frequently Asked Questions**

#### Q: What should my child wear for Xcelerate?

A: Camps are scheduled in air-conditioned classrooms that may be cool, but many camps will take advantage of nice summer weather and spend time outside as well. We suggest dressing in layers and wearing comfortable play clothes and shoes. A free Xcelerate shirt is given with every camp session and can be worn every day. Please note that some of the science and art camps can get messy. Please also note any specific clothing requirements for specialty camps such as Horseback Riding or Xcelerate Ninja Warrior.

#### Q: Can I send my child with snacks or drinks to Xcelerate?

A: Students are allowed to bring a small, non-messy snack or drink (in a bottle or other container with lid) from home, except for preschool camps. Snack times are not offered during the camp day, however students may enjoy their snacks during regularly scheduled breaks. It is recommended that students in high activity camps such as Horseback Riding and Xcelerate Ninja Warrior bring a water bottle every day. Please note that some camp locations, including computer labs, may not allow the consumption of food or drinks in the classroom.

If your child is registered for Relaxation Station, they should be sure to bring a non-refrigerated sack lunch and beverage.

#### Q: What should my child bring to Xcelerate?

A: Most importantly, every Xcelerate student needs to bring their complete Waiver and Release form that can be found as part of this packet. If a student is registered for Relaxation Station, they should also bring a non-refrigerated sack lunch.

Students should not bring any item with monetary or sentimental value. Unless requested by an Instructor, electronic devices, toys, trading cards, etc. should not be brought to Xcelerate. Cell phone usage is not permitted while in the classroom. Please note that Community Education is not responsible for lost or stolen property.

#### Q: My child is feeling a little under the weather. Can they still come to Xcelerate?

A: For the protection of all students, any child that exhibits signs of fever, vomiting or any communicable disease such as chickenpox, ringworm, lice, pink eye, etc. should not attend Xcelerate. If a student shows any sign of illness, rash, high temperature, infection, lice or any contagious illness, the parent/guardian will be called and asked to pick up the child.

#### Q: My child needs medication during Xcelerate. Can you give it to them?

A: Waubonsee staff do not administer or distribute any kind of medication during Xcelerate. Staff can remind students to take their medications. Students may carry their own medication with them, but please indicate which medications they will be carrying on the Student Information Form.

#### Q: My child has a nut allergy. Is Xcelerate a nut-free zone?

A: No. Waubonsee Community College is not a nut-free zone. If your student has a severe nut or other allergy please note it on the Student Information Form. Please also mention it to the instructor so that they can ensure a "nut free" zone during breaks when snacks can be consumed.
